## General Agreements

Ellie May's Daycare agrees to exercise due and reasonable care, to keep the premises sanitary and properly enclosed. The dog(s) will be fed properly and regularly as instructed by the owner, with the owner's provided food and will be housed in clean, safe quarters. If the owner fails to provide food, the dog(s) will be fed food provided by Ellie May's Daycare and the owner agrees to pay \$1.00 per cup for said food.

All dogs are handled or cared for by Ellie May's Daycare staff without liability on Ellie May's Daycare's part for loss or damage from disease, theft, fire, death, escape, injury or harm to persons, other dogs or property, or for other unavoidable causes, due diligence and care having been exercised. While Ellie May's Daycare will do its best to provide a safe environment for breeding females, Ellie May's assumes no responsibility for accidental pregnancy.

The Owner certifies to Ellie May's Daycare that their dog(s) is/are up-to-date on the required vaccinations and that their dog(s) most recent fecal exam was performed (within the last 12 months) and owner confirms that no parasites were detected. Owner agrees to update their dog(s)' vaccinations as needed and agrees to have a fecal exam performed every year and to disclose results as soon as they are received.

The Owner also certifies that their dog(s) is/are in good health and have not been ill with any contagious diseases or conditions in the last 30 days. Owner agrees not to attend daycare with their dog(s) if they come down with any symptoms of sickness including but not limited to coughing of any kind.

The Owner certifies and may be required to provide documentation showing that their male dog(s) are neutered and may be responsible for damages and cost associated with accidental pregnancy of other clients of Ellie May's daycare.

The Owner certifies that to the best of their knowledge, their dog(s) do not have an aggressive behavior problem and represent that their dog(s) has/have never bitten a person or another animal. Owner agrees to disclose all such incidents of which they are aware. **INT:\_\_\_**

The Owner understands that Ellie May's Daycare reserves the right to refuse admittance of their dog(s) at any time without recourse if issues arise such as aggression, property damage, or other unacceptable behavior. **INT:\_\_\_**

The Owner agrees that there are certain risks when dogs are allowed to socialize with other dogs and/or are in the proximity of dogs, including injury or illness. **INT:\_\_\_**

The Owner understands and agrees that Ellie May's Daycare staff reserves the right to administer treatment and/or use any available veterinarian for their dog(s) should the need arise whether or not Ellie May's Daycare can reach him/her or any other emergency contact provided by the Owner. Owner agrees that all expenses for any veterinary care provided to the dog(s) shall be paid by the Owner at the time of pick-up of the dog(s). **INT:\_\_\_**

The Owner agrees that their dog(s) may be photographed, videotaped, and/or recorded, and that Ellie May's Daycare shall have exclusive rights to use these images and their proceeds, to copyright, to use in any and all media, advertising, promotions, and to license to others in any manner. **INT:\_\_\_**

The Owner agrees to pay for any damages to the facility that is caused by their dog(s). **INT:\_\_\_**

The Owner is aware of the hours of operation of Ellie May's Daycare. The Owner is aware that a late fee of \$10.00 to each 30 minutes after closing will be added to the fee when applicable unless other arrangements have been made.

The Owner understands that if they do not pick-up their daycare dog(s) by closing time in case of emergency, their dog(s) may be boarded overnight and they agree to pay an additional overnight charge of \$50.00 per dog which will be determined by Ellie May's Daycare Staff. The owner also agrees to make arrangements to pick-up their dog(s) the following day. **INT:** \_\_\_\_

Owner agrees that their dog(s) shall not leave the facility until all charges are paid by the owner. Ellie May's Daycare shall have and is hereby granted a lien on the dog(s) for any and all unpaid charges resulting from daycare or boarding of the dog(s). **INT:** \_\_\_\_

### **Daycare Agreements and Policies**

The Owner is aware that the daycare fee will be posted at Ellie May's Daycare at the time of drop-off and that this fee is subject to change at any time, without notice.

Dog(s) that register for full time daycare for requested day(s) per week and owner is requesting daycare to reserve the agreed days, will be reserved and subject to charges based on the dog(s) agreed attendance at Ellie May's Daycare, whether in attendance or not. Failure of payment may result in the loss of the reserved day(s).

Part time dogs shall be charged based on agreed scheduled day(s) and will be charged accordingly. Owner must agree to give notice of 24 hours prior to daycare arrival if attending on a non-scheduled day. Part-time Owner understands that daycare services are not guaranteed and Ellie May's Daycare reserves the right to turn down daycare serves without notice.

The Owner is aware that Ellie May's Daycare reserves the right to charge them for daycare they have scheduled and missed. **INT.** \_\_\_\_

### **Waiver, Hold Harmless and Indemnification**

I hereby waive and release Ellie May's Daycare, its agents and employees for any injury or damage my dog(s) may suffer, including specifically, but without limitation, any injury or damage resulting from the action of any dog also being housed or attending daycare or any other function by Ellie May's Daycare, while on the premises. **INT:** \_\_\_\_
